On conducting practice for higher education students of
Kamianets-Podilskiy Ivan Ohiienko National University

We, the undersigned, being Kamianets-Podilskiy Ivan Ohiienko National University (EDRPOU Number 02125616 (hereinafter – Institution of Higher Education) on one side, represented by Principal **Serhii KOPYLOV**, who acts in accordance with Kamianets-Podilskiy Ivan Ohiienko National University by-laws, and *Ukrainian Youth Association of Canada* (hereinafter – Practice Base) on other side, represented by the Head of Association **Mykhaylo Kozlovskyy**, who acts in accordance with Ukrainian Youth Association of Canada by-laws, conclude this agreement on conducting practice for higher education students.

1. Practice Base commits:

1.1. To accept University's higher education students of specialty 052 Politology, Politology curricula for practice in accordance with Schedule (Appx. 1) (Higher education students list and practice dates).

1.2. To assign qualified specialists to oversee practice process.

1.3. To provide environment appropriate for practice conduction by higher education students, prevent putting students into operation until jobs are properly assigned and conducting work that does not correspond to practice program or future specialty.

1.4. To provide higher education students with safe work conditions in specific workspace. Conduct mandatory labor protection briefings: introductory and inside a workspace. Instruct higher education students on safe working practices, if needed.

1.5. To provide opportunity for higher education students to use logistical supplies and informational resources, necessary for practice program's execution.

1.6. To keep record of higher education student-practitioner's job performance. Report to Institution of Higher Education in case of any violations of labor discipline, internal schedule and others.

1.7. To provide work reference for every higher education student, which expresses practice program completion, quality of work, etc., after practice is concluded.

1.8. To provide opportunity for higher education students to collect data on business organization for their term papers, based on study department's directives, if such actions will not breach business confidentiality.

1.9. Additional terms: higher education students' work is conducted on basis of unpaid labor.

2. Institution of Higher Education commits:

2.1. To provide Practise Base with a practice plan for confirmation, with a list of higher education students meant to attend practice, before the program starts.

2.2. To assign qualified lecturers to oversee practice process.

2.3. To ensure proper labor discipline and internal schedule adherence by higher education students, To take part in committee investigation in case of accidents that involve higher education students and occurred during practice.

2.4. Institution of Higher Education commits to ensure non-disclosure of any information used in term papers by destroying said papers in the established manner.

3. Liability for nonperformance of agreement:

3.1. Sides are liable, in accordance with Labor Code of Ukraine, for nonperformance of their respective responsibilities towards organization and conduction of practice.

3.2. All disputes between the sides related to terms of agreement are to be resolved in due order.

3.3. Agreement comes into force from the moment of signing by both sides and remains active until 2027/06/30 (30 June, 2027).

3.4. Agreement is composed of two copies, one for Practice Base and one for Higher Education Institution.
